which established the present-day Commonwealth of Puerto Rico.⁶ In four subsequent plebiscites, Puerto Ricans have declined to alter that status in favor of becoming a state or an independent sovereign nation.⁷

The U.S. Constitution provides that "[t]he Congress shall have power to dispose of and make all needful rules and regulations respecting the territory or other property belonging to the United States."
