Re: Unsubstantiated Claims for Opavirus Prevention or Treatment

To Whom It May Concern,

This is to advise you that FTst ff reviewed your website https://utopiawellness.com/ on May 24, 2020. We have determined that youale wfully advertising that certain products or services treat or prevent coavirus Disease 2019 (COVID-19).

Some examples of Coronavirus treatmemprevention claims on your website include:

- x In marketing materials titled "Coronavirus A Proactive Approach," you claim that:
 - o "So how do we rid ourselves from a will infection? We do so through our immune system. The stronger your immusyetem, the quicker you will heal. This is why some people are suscepttble or or or other people die and yet another subset never gets ill."
 - o "So what can I do to protect myslé against coronavirus today?... Fortify your immune system is ke[/] I use several methods that help build my immune system. First, I take daily supplements that include vitamin C, zinc lozenges and vitamin D3. These areay go to preventative and tierventional supplements. I also add additional high doses of vitamin C [link to https://utopiawellness.co/immune-booster/] thoughtravenous injection."
 - o "My regimen for prevention also inucles colonic irrigation [link to https://utopiawellness.com/services/coloerthpy/]. This therapy is ignored and maligned by practitioners who have neverplemed its benefits, let alone tried it. Remember, the transverse colon is the praour body that makes our lymphatic

fluid, an essential component in a healthy immune system."

o "Clinically, this three-prong approcal of <u>detoxification</u> [link to https://utopiawellness.com/services/defiocation/], immune fortifying IVs and expectoration, have provided me and prayrients with dramatic symptomatic relief and a shortening of disease process."

It is unlawful under the TC Act, 15 U.S.C. § 4et seq. to advertise that a product or service can prevent, treat, or cure hundissease unless you possess competent and reliable scientific evidence, including, when propriate, well-contited human clinical studies, substantiating that the claims are alture time they are nade. For COVID-19, no such study is currently known to exist foethroducts or services identified above. Thus, any Coronavirus-related prevention or treatmosailms regarding such products or services are not supported by competent and reliable nsidic evidence. You must immediately cease making all such claims.

You are also advised to view all other claims for our products and services and immediately cease making claims there not supported by competent and reliable scientific evidence.
